 - (iii) Forfeiture of security money in part or full; and

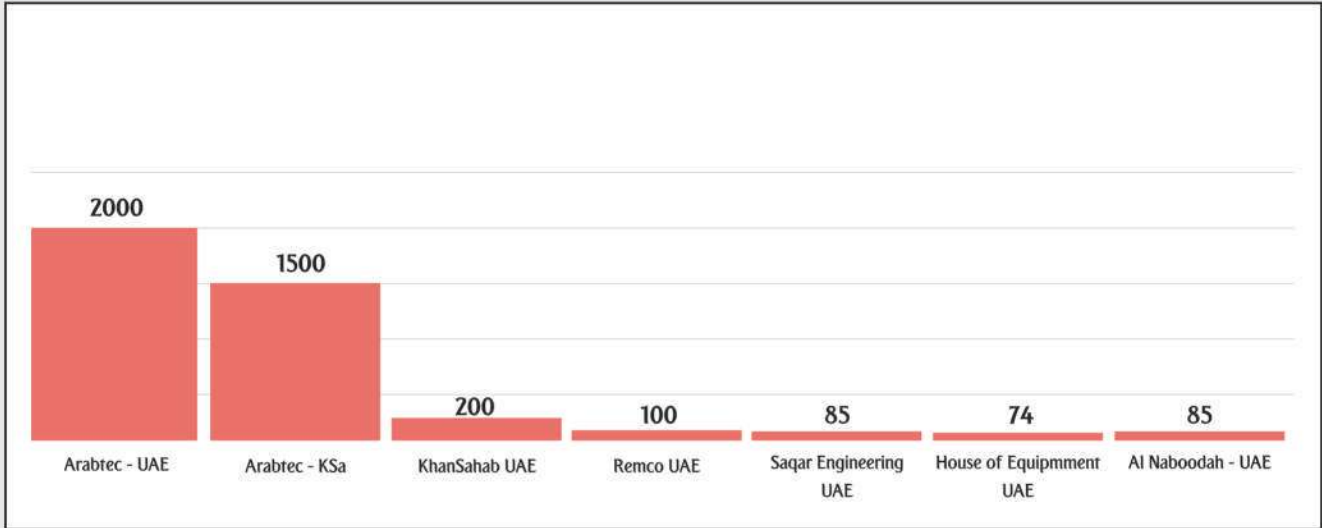

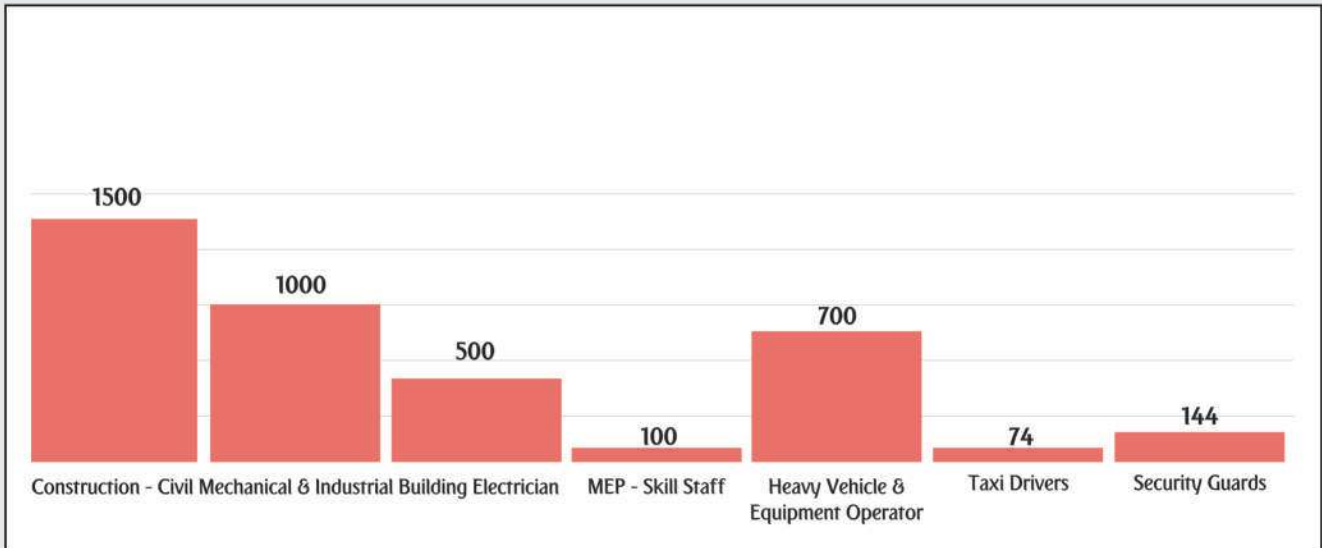
